



# OLYMPIC SKIBOWL SKI & SNOWBOARD SCHOOL

Please read carefully! This is a release of liability and waiver of certain legal rights.

Participant understands that skiing, snowboarding, ski and snowboard racing, snow play, ski and snowboard lessons, competitions, and any other use of Olympic Skibowl Ski School (DBA Olympic Skibowl Ski & Snowboard School), or Mt. Hood Ski Bowl LLC's, premises and facilities, (collectively referred to as "Sports Activities") can be hazardous and that injuries are common when participating in Sports Activities. Participant accepts and assumes the risks associated with Sports Activities, including, but not limited to, changing weather conditions, variations and steepness in terrain, terrain features and parks, snow or ice conditions, avalanches, surface or subsurface conditions, bare spots, creeks and gullies, forest growth, rocks, stumps, the uses of lifts, collisions with natural or man-made objects or other persons, grooming and snowmobile equipment, lift towers and other structures and their components, falling, loss of control, the setting and location of race courses, the design and location of tubing facilities, the selection of terrain, and exceeding one's ability. Participant hereby freely and expressly assumes any and all risk of property damage, injury, and death associated with Sports Activities.

I understand and agree that this lesson may take place in a variety of terrains and conditions, including but not limited to, terrain parks and other freestyle terrain. I understand that this lesson may take place in a terrain beyond my ability and that I am solely responsible for this election and use of any terrain that may be encountered in this lesson.

In consideration for the participation in any Sports Activities and the use of any other Olympic Skibowl Ski School or Mt. Hood Ski Bowl, LLC facilities and premises, Participant hereby agrees to release, hold harmless and indemnify Olympic Skibowl Ski School, Mt. Hood Ski Bowl, LLC and its owners, partners, employees, directors, officers, agents, affiliates, and related entities from any and all claims by or on behalf of Participant against Mt. Hood Ski Bowl LLC or Olympic Skibowl Ski School arising directly or indirectly out of Participant's participation in any Sports Activities and/or participant's use of Olympic Skibowl Ski School or Mt. Hood Skibowl LLC's facilities and premises. This release includes the claims and liabilities arising from any cause whatsoever, including, but not limited to, negligence on the part of Olympic Skibowl Ski School or Mt. Hood Ski Bowl LLC. Participant also agrees to indemnify (including costs and attorney's fees) Olympic Skibowl Ski School or Mt. Hood Ski Bowl LLC for any claim brought on behalf of a minor named in this agreement. Participant accepts responsibility for any and all medical bills arising out of Sports Activities at Olympic Skibowl Ski School or Mt. Hood Ski Bowl LLC.

In the event of any claims or litigation arising out of or in connection with participation in any activity at Olympic Skibowl Ski School or Mt. Hood Ski Bowl LLC, the venue for legal proceeding shall be Clackamas County, Oregon. If any term is declared to be invalid hereunder, the remaining terms of this agreement shall continue to be enforceable. The purchaser or user of this lesson agrees to comply with skier duties and responsibilities under ORS 30.980 and ORS 30.985
